

Comparable Bike Share Systems






Turnkey Contract

- Vendor is responsible for:
 - Providing / installing / maintaining bike share stations
 - Providing / owning / maintaining / rebalancing bikes
 - Replacing bikes as needed
 - Providing / maintaining smartphone app for bike rentals (with back-end for vendor and City to monitor bikes and rides)
 - Collecting user fees and memberships and remitting to City
 - Seasonal storage of bikes
 - Insurance / liability
- RFP will allow for vendor to be entrepreneurial securing additional funding to grow the program, subject to City approval

Initial Scale and Growth

- 2025 Start with 5-6 stations and 30-35 bikes
 - Use the Clipper City Rail Trail as the initial spine
- 2026 Grow to 9-10 stations and 45-50 bikes
 - Expand to key destinations, such as
 - Parker River National Wildlife Refuge
 - Maudslay State Park
 - Anna Jaques Hospital

Impact on Multiuse Trails

Existing Saturday bike volumes (September 2023 estimate)

CCRT near High Street bridge: 400 bikes

CCRT near Osprey sculpture: 320 bikes

Estimated daily bike share rides

2025: 16

2026: 36

2027: 48

Maximum impact on trails: +5% in 2025, rising to +15% in 2027
